If you would like your employer to make your superannuation contributions to your QSuper account, you can complete this form instead of the *Australian Taxation Office (ATO) - Standard Choice form*.

Please return your completed nomination form directly to your employer. Do not return this form to QSuper.

QSuper's statement of compliance

This statement confirms that the QSuper Board (ABN 32 125 059 006, AFSL 489650), as trustee for QSuper (ABN 60 905 115 063), is a complying resident and regulated superannuation fund within the definition of the *Superannuation Industry (Supervision) Act 1993* and is also an authorised MySuper product.

The Australian Prudential Regulation Authority (APRA) has not issued a notice of non-compliance or advised the QSuper Board to not accept employer contributions.

¹ An employer is authorised to collect an employee's TFN under the *Superannuation Industry (Supervision) Act 1993*. It is not an offence for an employee not to quote their TFN. However, quoting a TFN reduces the risk of administrative errors and if the employee does not quote their TFN their contributions may be taxed at a higher rate. An employee can get more details regarding their privacy rights by contacting their superannuation fund.



Types of contributions you can make

QSuper accepts all contribution types, including employer and personal contributions.

In most cases, you do not have to join the fund your employer nominates. However, in some circumstances you may not be eligible to have your employer contribute to QSuper and you'll need to check this with your employer.
