**3 Providing your tax file number**

Under the *Superannuation Industry (Supervision) Act 1993*, your super fund is authorised to collect your tax file number (TFN), which will only be used for lawful purposes. These purposes may change in the future as a result of legislative change. If you transfer your super to another fund we may disclose your TFN to the other super provider unless you tell us not to in writing. It is not an offence not to quote your TFN. However, providing your TFN to your super fund will have the following advantages (which may not otherwise apply):

- Your super fund will be able to accept all types of contributions to your account(s)
- The tax on employer contributions to your super account(s) will not increase
- Other than the tax that may ordinarily apply, no additional tax will be deducted when you start drawing down your super benefits
- It will make it much easier to trace different super accounts in your name so that you receive all your super benefits when you retire.

**Your TFN**

If we already have your TFN, you do not need to give it to us again.

## 4 Declaration and authorisation

- I know I can contact my other super fund to find out if transferring this money will affect my benefits with them. By signing this form, I am letting you know that I have either received this information from them, or I do not need any more information.
- I am the person named on this form, or have a power of attorney to act on the member's behalf.<sup>3</sup>
- I want QSuper to arrange the transfer of my money from my other super fund to my QSuper account.
- Once payment is made to QSuper, if I've selected to transfer my full balance from the other super fund, I understand this will close my account with that super fund.
- I have read and understood the *QSuper Product Disclosure Statement (PDS) for Accumulation and Income Accounts*.
- I want any contributions received by the other super fund, after my benefit is transferred, to be paid to QSuper.
- I understand my other fund/s may contact me to ask for documents to satisfy their proof of identity requirements.
- I understand that my transfer will be invested according to my current investment strategy.
